November 14, 2021 - PHRF-LE MEETING MINUTES - Houlihan's Westlake

Attendance: Ryan, Merkle, Burris, Schiavoni, Daley, Earhart, Kellner Quorum was present; 5 of 10 voting members were present.

Administrative – Meeting was called to order at 10:30am. Minutes from the October 19, 2021 meeting were reviewed and approved. Meeting adjourned at 1:30pm

MODIFICATIONS

Benet 36.7 – Michael Karns/Grand River - 7'-4" keel, has a bowsprit of 23". The 12% rule limits this to 18-3/4". He's 5" over. The 5" is 2.8% of the max "free" TPS. He will be limited to Asy spinnakers with this. Dave suggested a 3-second adjustment for oversized sprit is fair according to our rules. Mr. Karns ultimately went to South Shore which shows the add-on sprit at 15% larger than the J with no penalty. He did pay for LE certificate. Never provided jib foot roach but used South Shore certificate to grant the roller furling credit. South Shore rating is 81 PHRF and 88 JAM. The Committee confirmed the -3 to the base rating for the oversized sprit and will be asymmetrical spinnaker only. PHRF-LE rating is Base 78 PHRF and 88 JAM. Passed unanimously.

Benet 265 – Jim Schiavoni/Buffalo - re-classify rating as a "Sprit Boat" Asymmetrical only under 11.6.2.5. Change Class to Custom as boat does not have spinnaker pole. Boat is a Fractional rig, the Rig book has the I dimension at 31.33 but does not list a dimension for ISP. We estimate the Spin halyard exit point is located approx. 4 inches above the Jib halyard exit. The new sprit measures 36" from headstay center pin to TPS. This modification will incur -3 for the add-on fixed sprit and will be asymmetrical spinnaker only. Future sails must be the same size as the symmetrical area. Passed unanimously with 1 abstain due to conflict.
